<u>1 – Anesthesiologist</u>

I. Anesthesiologist Qualifications

- Graduate of medical training resulting in highest level of degree/diploma available as a physician/Doctor of Medicine.
- Graduate with specialty training in anesthesia and achieved the highest level of certification available.
- Current certification and/or license to practice medicine/anesthesia in home country without restrictions.
- Currently practices anesthesia a minimum of 20 hours a week (adults and pediatrics).
- Provide anesthesia with a minimum of 20 cases per year for children less than 5 years of age.
- Certified in Pediatric Advanced Life Support (PALS) or equivalent course required.
- Certified in Advanced Cardiac Life Support (ACLS) or equivalent course is recommended.

I. Pediatric Anesthesiologist Qualifications

- Graduate of medical training resulting in highest level of degree/diploma available as a physician/Doctor of Medicine.
- Graduate with specialty training in anesthesia and achieved the highest level of certification available.
- Current certification and/or license to practice medicine/anesthesia in home country without restrictions.
- Currently practice anesthesia a minimum of 20 hours a week.
- Provide anesthesia with a minimum of 100 cases per year for children less than 5 years of age.
- Provide anesthesia with a minimum of 40 cases per year for infants (0-1 year of age).
- Certified in Pediatric Advanced Life Support (PALS) or equivalent course required.
- Certified in Advanced Cardiac Life Support (ACLS) or equivalent course is recommended.

I. Anesthetist Volunteer Qualifications

- Graduate of medical training resulting in highest level of degree/diploma available in-country.
- Graduate with medical training in anesthesia and achieved highest level of certification available.
- Current certification and/or license to practice anesthesia in home country without restrictions.
- Currently practices anesthesia a minimum of 20 hours a week (adults and pediatrics).
- Provide anesthesia with an average of 10 cases per month for children less than 5 years of age.
- Certified in PALS or equivalent course required.
- Certified in ACLS or equivalent course is recommended.

II. Anesthetist Credentialing Pathways

Application Process - Submit:

- Completed Operation Smile Application form.
- Curriculum vitae (resume) detailing current experience.
- Certificate/degree for medical/nursing training.
- Further diploma or fellowship in anesthesia training.
- Current license to practice medicine/anesthesia in home country without restrictions.
- Current PALS or equivalent (required).
- Current ACLS or equivalent (recommended).

NOTE: An additional Interview may be required with the Foundation Volunteer Management Team and/or Operation Smile Council member or chair.



Participation on programs is dependent upon:

- Following verification of documents, applicants must receive positive skills evaluations by a credentialed, experienced anesthesiologist or anesthesia team leader on a minimum of 3 programs.
- Maintaining current licensure, certifications, and documents as applicable.
- Having PALS or an equivalent (within 2-years of date issued).
